POST OF ASSISTANT ENGINEER

Required Qualifications:

- Should have a B.Sc Engineering Degree specializing in Civil Engineering from a University/ Higher Educational Institution recognized by the UGC and the Institution of Engineers Sri Lanka (IESL) and registered as an Associate Engineer or above at the Engineering Council of Sri Lanka (ECSL).

OR

- Should have a Bachelor of Engineering Technology (BET) degree specializing in Civil Engineering Technology or Construction Technology from a University / Higher Educational Institution recognized by the UGC with at least two (02) years of experience in Civil Engineering works in a recognized establishment and registered as an Affiliate Engineer or above at the Engineering Council of Sri Lanka (ECSL).

OR

- Should have a National Diploma in Technology specializing in Civil Engineering or equivalent with at least seven (07) years of experience in Civil Engineering works in a

recognized establishment and registered as an incorporated Engineer or above at the Engineering Council of Sri Lanka (ESCL).

- Should be a citizen of Sri Lanka
- Should be below 45 years of age on the closing date of applications
- Should be of good character and sound physical health
